Meeting called to order by PJ Slobojan at 10AM.

<u>Agenda 1 - Welcome</u>: President's explanation: voting rights and speaking rights; review of involvement in the Project Renewal Run on April 21, 2012; report on the 3'n1 cards to date; report on distribution of directories.

<u>Agenda 2 – Sec'r Report:</u>, Secretary's Report; moved and approved.

Agenda 3 – Treas. Report: Treasurer's Report. Sara Bartholomew reviewed; moved and approved.

<u>Agenda 4a Scott St. Steps</u>: Mike Ryan report on Scott St. project: Phase I completed with the setting of the rails to the walls at alley entry; Phase II, options reviewed, including (i.) double rails to the lower half of the staircase; (ii.) one rail extending the entire staircase, (iii.) greater spacing between rails. A CPP grant has been applied for to include the lower half, both sides, more spacing between spindles.

<u>Agenda 4b</u>: PJ report on <u>Beautification</u>: Discussion of Western Ave lights and status of utility payments and maintenance responsibilities between the association and the City, with the City now paying the utilities and whether they will also maintain; cited - 1990 ruling regarding private improvements to public property.

MOTION by Mike Ryan, seconded by Dave Cordes: That \$200 be allotted to hire an electrician to assess the condition and needed repairs of the Gaines Street lights and provide an estimate and warranty terms. MOTION CARRIED.

Dave Cordes reports that the Ripley Street lights are repaired.

Spring Clean-Up: report that tree needs removed; report on poor turn-out for clean-up day in 2011; call for better participation in 2012.

<u>Agenda 4c</u>: Mary Houston report on <u>Membership</u>, to-wit: membership now stands at 60 with newest additions being the Woods and the Canfields.

<u>Agenda 4d</u>: PJ report on <u>Committees & Volunteers</u>; list of current committee chairs and members; call for additional participation.

<u>Agenda 5 Election: -</u> Call for the election of Mary Houston for the At-Large position, corrective measure/ technicality; MOTION to close the nomination process by Jack Haberman seconded by Mike Schroeder; vote; MOTION CARRIED electing Mary Houston to the position of At-Large board member.

<u>Agenda 6 Budget</u>: PJ report; (i.) Estimated income includes \$200 from treasury into Brown St. fund;; (ii.) Utilities - reduced over last year to reflect City taking utility costs for Western lights; (iii.) Celebration Cocktail Party, new line item; (iv.) 2012 Weed&Seed basketball event snacks, Marion reports this event is past; both PJ and Marion report lack of contact from sponsoring officials; funds unused; (v.) new line item

for \$200 on neighborhood promotion targeting bankers and realtors; (vi.) new line item for \$50 for conference expenses, e.g., grant-writing conference. MOTION to approve the budget by Steve Bartholomew including language to move the \$80 from the unused basketball event funds to the Neighborhood Promotion fund; MOTION CARRIED.

<u>Agenda 8</u>: New business, re 510 W. 6th St. DISCUSSION. MOTION by Penny Rhomberg to terminate discussion of 510 W. 6th St., as not within the function and mission statement of the GC-HHD Association; seconded by Jeremy Keninger. MOTION FAILED.

MOTION made by Marion Meginnis to hold a special meeting in March for purposes of continuing discussion of 510 W. 6th St.; protocal requires one of 2 options for special meetings, one being vote of three board members; three board members VOTE to have special meeting to continue discussion in March, 2012, date TBA.

GH-HHDA Special Meeting of the Membership Minutes

Saturday, March 31, 2012, 10:00AM, @ Community Room, Davenport Police Department, 416 N. Harrison St., Davenport, IA.

Present: Taken by circulated Roll Call, attached.

Agenda: Property at 510 W. 6th St.

Meeting called to order by PJ Slobojan at 10AM. A brief background of the issue of the stabilization of 510 W. 6th and the GC-HHDA possible involvement in this was given. Protocol on Robert's Rules of Order was given.

*Motion made by Sara Bartholomew and seconded by Jeff Gomez to vote by ballot on any motions of this meeting. Motion carried.

*Motion made by Sara Bartholomew and seconded by Glenn Peterson to limit any debate to 2 min. Motion carried.

*Motion made by Mike Schroeder and seconded by Jeff Gomez to state the following:

"We, the members of the Gold Coast-Hamburg Historic District Association, support saving the home at 510 W. 6th St., because of its monumental historical significance, architectural beauty, and prominent location with the neighborhood. Further, this is to be communicated in a letter the Davenport Mayor, Council, City Staff, Historic Preservation Commission as well as the property owner."

Discussion followed. The motion was passed 32 yes, 1 no.

*Motion made by Marion Meginnis and seconded by Glenn Peterson to state the following:

"That the Gold Coast Hamburg Historic District Association adopts the following resolution and that it be

shared via letter with the Mayor, City Council, and City Manager, and homeowner of 510 W. 6th St.

We the members of the Gold Coast-Hamburg Historic District Association, as outlined in our mission statement, are 'dedicated to preserving the built heritage of Davenport's First Neighborhood.'

One of our most important homes, the Lambrite-Iles-Petersen Home at 510 W. 6th St., is deteriorating at an alarming rate, causing concern for its survival. The home has been declared uninhabitable by the city and has not been lived in for more than two years. Requests for action from the city and utility companies have gone unanswered. All offers of assistance by neighbors, friends, and the Association have been rebuffed.

We now ask for the City of Davenport's aid in assuring the home's survival and pledge our support for any future efforts to accomplish that end."

An amendment was made by Aubrey Jordan and seconded by Marion Meginnis to add the words "if possible" in the last paragraph after the word "survival". This amendment was defeated.

After discussion on the original motion, a ballot vote was taken and motion passed with 23 yes, 9 no, 1 abstain.

It was discussed and agreed upon by consensus that both motions will be included with correspondence to the city. The board will draft and send the letter and send copies to membership.

*Motion was made by Sara Bartholomew and seconded by Jill Sidney stating "at this time the GC-HHDA table any direct action/intervention in the matter of 510 W. 6th St. until August 2012." A friendly amendment "except to respond to any correspondence or requests from the City" was added to the motion. After discussion the motion and second were withdrawn.

*Motion by Jeff Gomez and seconded by Mike Ryan that "a draft of policy for abandoned property be presented at the May 2012 membership meeting with a final draft and vote at the August 2012 membership meeting." After discussion, this motion was passed after agreement by the body not to do a ballot vote.

Meeting was adjourned at approx. 11:30.

- Communications. 1) The Board received notification from a man interested in endorsing help from the Assoc. to purchase/restore the Col Ballroom. One of his ideas for parking was to tear down housing north of 5th St. Board replied tearing down housing would not be met with approval, but would endorse any attempts to restore the Col. Bill Boom and PJ met with the party and encouraged him to find parking as a first step in the process. 2) Bill Boom as Aldernman and PJ from GC-HHDA attended the State APA conference in Ames and, along with Matt Flynn and Roy DeWitt, gave a presentation on Davenport's NEW (Neighborhood Empowerment and Wellness) program. 3) 518 Brown has been purchased by Ecumenical Housing, and early on, there were discussions of possibly razing the building. It now appears they will renovate to rent or sell.
- 6. General Reports

- a. Liaison Dave Cordes met with Matt Flynn and Ryan Rusnak from the City concerning down zoning. 2 options came out of the meeting. One is to meet with owners of multiple dwellings individually and see who may be willing to go through the downzoning process. The other option is to work to downzone the entire district at once. Dave recommended the board begin the process of talking to individual owners. He has a list of these multiple dwellings that are referenced. Marion Meginnis reported Weed and Seed is no longer being funded, but monthly policing meetings will continue, and members were encouraged to attend these meetings. Mike Ryan is continuing to work with multiple dwelling homeowners to purchase city garbage containers to help save the streets and alleys from additional heavy private trucks using these. PJ is working on infrastructure item with nothing significant to report plus concerns with city that relate specifically to our neighborhood.
- b. Promotion Mike Schroeder Neighborhood "Homes for Sale" open house was held September 23, 2012 from 12pm to 4pm and kick-off reception was September 2012 from 3 to 6pm \$1000 budget was approved for marketing and putting on the event and approximately \$60 over budget was spent.
 8 homes were open that day with about 400 people attending, and deemed a success.
- c. High Tea Sara Bartholomew and PJ reported 24 advance reservations at this time with a possible 48 seating for the Dec. 8 event. Media promotion is being done and there is still a need for volunteers.
- d. Financial Planning The Board is taking over this project. A list of possible projects has been generated and the work will continue.
- e. Beautification PJ reported most of the work this year has been maintenance along with the Scott St. project. An end of year report was given to members.
- f. Bylaws and Policy The policy on abandoned property was included in the policy document and given to members.
- g. Membership Membership is at 71 for 2012, the highest yet for the Assoc.
- h. Walking tour brochure Sara gave numbers from AEA for the walking tour brochure. Membership voted to have 500 copies with one color added on the front cover for \$634. After that batch is gone, there will likely be some new editing and sales to advertisers for re-prints.
- i. The Annual Plan was presented.
- Elected officers for 2013 are Terry Genz, Vice President; Dave Cordes, Treasurer; Redmond Jones, At-Large. Present Board members were thanked for their service this year.
