 - d) Seal gazebo coordinate with first spring park cleaning.
 - e) General park maintenance revert back to a neighborhood clean-up rather than individuals volunteering.
 - f) Recommend hiring mowing done -- get quote from Dan McDaniels
- 2. Western St. Railing

We have bids, ready to go - present these at next meeting and get membership approval for committee to go ahead on project, using Kelly Construction (\$2787) for concrete work and Eldridge Ironworks for railing. We have American Iron bid for \$2250.

- 3. Ripley Street, repair of steps and hand rails, addition of lights -- Volunteer the beaut. committee to continue with this project, along with any other interested members. Step one would be contacting city as their responsibility, etc. The Bartholomews, Troy Smith, Terry, PJ volunteered to work on this.
- 4. Apply again for leaf bag grant About 40 bags are left from last year, and those were distributed at the meeting. Free pickup weeks are 4/5-16 and 10/18 through 11/27.
